He recognizes that the DDA may not have any ability to correct the situation and he has spoken previously to the Almont Village Manager and wanted to make sure that all parties are communicating. He stated that Joe Israel has been very helpful throughout the process in addressing his concerns. As an owner of a rental property he has to comply with the property maintenance codes and hopes that the project owner is being held accountable as well. T. Roach acknowledged the concerns and asked that DDA Director N. Boxey perhaps draft a letter to the Village Council stating that the DDA is frustrated with the lack of progress in correction of this community eyesore. N. Boxey assured Mr. Lutz that she is in close contact with the Village Manager regarding this project and that several citations have been issued per the property maintenance code.
