DIRECTORS REPORT:

Summary: Angela has worked on the Social District considerably—presentations to the Village Council, in collaboration with Village Manager; time spent to carry out the 1st Annual Chili Crawl; continues to compile a list of DDA businesses; MDA conference next Tues/Wed; Meetings: Village Council, Department head, Event committee, Social District meetings, met with MDA Director Dana Walker and Lapeer County DDA directors.

NEW BUSINESS

A. Communication

1. Lapeer County EMS letter

Facts: Russel Adams, Executive Director for Lapeer County EMS, has asked whether the Village of Almont DDA will continue to agree to forego "capture" of revenue from the 2020 special levy money that a Lapeer County EMS millage request approved by voters would provide. In a letter he respectfully asks that the Almont DDA continue this agreement regarding the special millage revenue generated if the voters approve the 2024 ballot request. An answer by March 6 has been requested. Discussion: M Schneider asked how much the capture is and what other municipalities forgo capture in Lapeer County? After a call in to Mr. Adams, he stated that the City of Lapeer captures funds in the amount of approximately \$7,000—he could not give us our capture total so our assumption is that the funds the Almont DDA captures are much less. Motion to continue to forgo the capture from the levy money, contact Mr. Adams and draft a letter of intent.

DISCUSSION:

- A. **Social District:** The Village Council has approved the resolution, 6 to 1, to designate a social district with changes to the original proposal. Approved days are Wednesday through Sunday, with weekday hours of 3pm-10pm and weekend hours of 1pm to 10pm. Chicky's has been added to the district area but does not have a common area in front of her establishment. Adding a common area behind her business will have to be worked out.
- **B. Earth Day Clean Up:** Earth Day is Monday April 22, 2024, clean up will be Saturday April 20, time to be determined after consulting with Almont Park Board.
- **C. Snow removal update:** Last year we spent almost \$41,000 for sidewalk & parking lot clearing. So far with our hourly contract with DPW, and the milder winter, we have spent \$2,413.91. That is a huge savings that will be pumped into facade grants and other district improvements.
- **D. Townopoly:** The Townopoly fundraising project will be tabled until our messaging system is in place.

OLD BUSINESS:

A. Chili Crawl: Our first annual Chili Crawl was a sold out success. Our restaurants reported that they were busier that day and they are looking forward to next year. Repurposed signage was used to warn drivers of a DDA event ahead as well as new pedestrian crossing signs acquired for all events. Among other small tweaks is the need for added registration table volunteers and sign placement volunteers.

BOARD QUESTIONS AND COMMENTS:

- Chairperson Roosa wanted to make note of how helpful Brian and the DPW has been to the DDA, from moving our district trash cans out for the Chili Crawl to problem solving traffic signage for event awareness. To address the comment at the Village Council meeting, the DPW removes about 1/2 of the trash cans for winter protection from salt and plowing, they were an expensive purchase that we will take care of. A Roosa also shared a conversation he had with the Howe's and the idea to suggest to the Park Board of moving Music in the Park night to the Jeep and Cruise Nights. M Schneider shared a few new ideas were discussed at the last Park Board meeting and suggested that getting the two boards together may invigorate attendance to Music in the Park.
- —M Schneider brought up the invitation from Village Council for the DDA Board to attend a Joint Meeting with the Council and the Planning Commission to discuss the Master Plan that has been put together. Tuesday March 5th at 7:30. A Roosa and Angela Edwards stated they could not attend due to conflicts.
