Attached are the (2) two forms that need to be completed and returned to the DDA to enter the parade. It is important that they be completed prior to the event so that we can coordinate our entry line-up and announcer notes.

In the interest of safety, no candy may be thrown from moving vehicles/floats or walkers. We ask that if you will be distributing candy, you do so by members of your organization walking near your entry and handing it out to spectators. We need to avoid having children dart out in front of moving vehicles.

Santa will be arriving at the end of the parade on a fire truck. To eliminate confusion of just who Santa is, please refrain from having your own Santa in your parade entry. Numerous Santa's can be very confusion to young children and lower the excitement of when he arrives.

This year's parade will take place on Saturday, December 7th. Line-up will begin at 6:00 pm and the parade starts at 7:00. Judging ends at 6:30- Must be in line prior to be judged!

IMPORTANT: Parade lineup will be in the Almont High School parking lot.

Entries will be judged based on the following criteria and prizes will be awarded in four categories: Business, Student Group/organization, Community Organization and Best of Parade.

- Keeping with the seasonal theme of the parade (lights). Your entry should reflect whatever holiday you
  choose to celebrate at this time of year.
- Use of holiday lighting.
- Innovative use of materials.
- Originality
